General conditions for the statement validity

- 1. The application is to be forwarded to RINA RAVENNA Office using RINA form for any single Purchaser's Order, indicating "Firm provided with RINA Alternative Testing Scheme (statement reference number)". RINA will send the relevant File Number to the Manufacturer.
- 2. The products are to be produced, inspected and tested in compliance with the Quality Control Plans/Inspection and Test Plans (Q.C.P./I.T.P.) approved by RINA. The names of the personnel appointed by the Manufacturer as responsible for any phase of the production and control process is to be clearly stated on relevant O.C.P./I.T.P.
- **3.** The Manufacturer is to agree with RINA the dates of execution of inspections and tests to be witnessed by RINA Surveyor, as required by the relevant Q.C.P./I.T.P.
- **4.** On completetion of the inspection and tests required by the relevant Q.C.P./I.T.P., the Manufacturer is duly authorised to issue the following documents:
 - 4.1 Certificate of Conformity (RINA Form "COLALT"), duly endorsed and marked on Manufacturer's field
 - 4.2 Manufacturer's relevant inspection and test reports signed by the appointed personnel.
 - 4.3 Evidence that the remarks on the approved drawings have been dealt with, as applicable.
- 5. One set of the above documents are to be sent to RINA RAVENNA Office before the delivery of the products. Upon satisfactory review of the above documentation, RINA RAVENNA Office will send back (by mail) COLALT certificates duly endorsed, stamped and the relevant invoice.
- **6.** Upon receipt of the certificates, the Manufacturer is authorized by RINA to mark the products with the RINA stamp and the RINA file number.
- 7. Products are to be delivered once provided with the RINA Stamp and the relevant RINA "Certificate of Conformity" COLALT duly endorsed by RINA.
- **8.** Any "non conformity notice" or "client/shipyard claim" is to be forwarded to RINA RAVENNA Office with relavant "corrective actions" taken as soon as possible.
- 9. The validity of the present Statement is subjected to the satisfactory result of the intermediate audits and the Manufacturer premises, carried out according to the table included in this attachment. RINA reserves all the rights to perform unscheduled audits.
- 10. Any modification to the initial conditions (e.g. relevant to design characteristics of the product, production and control procedures, suppliers of main components) are to be promptly communicated to RINA which reserved the right to require additional assessments.
- 11. In any case, RINA Surveyors are to be allowed to witness during the performance of production and control activities, upon their request.
- 12. RINA may suspend of withdraw the admission to the Alternative Inspection Scheme in the case of modifications to requirements or conditions for initial admission.
